- Financials: John provided a summary of the financials year to date.
  Overall Slightly over budget
  - Income Over Budget (Parking and Clubhouse Rental)
  - o Corporate Expenditures Under Budget
  - o Utilities Over Budget (due to Gas and Water)
  - Maintenance Over Budget
  - Repairs & Supplies Over Budget
  - o Overall Expenditures Over Budget

- Reserves Balcony Repairs, Tree Maintenance and Landscape Replacement paid from Reserves. Reserve balance increased over the year.
- o Delinquencies are minimal.
- Budget Approval:
  - BOD approved increase in property management fee for fiscal year 2017/2018.
  - BOD discussed proposed budget for 2017/2018. Due to a number of factors considered in both the operating budget and the reserve budget, the BOD agreed to an increase in HOA Dues.
  - $_{\odot}$  HOA dues for 2017/2018 to be increased to \$412.

- AT&T MDU Fiber Overbuild Project
  - Pre-Construction site inspection scheduled for August 11<sup>th</sup>.
- CC&R Amendment
  - BOD reviewed CC&R Amendment package. Package to be mailed to homeowners after Labor Day, with ballots due by October 6<sup>th</sup>.
- Feral Cats at CA School for the Deaf
  - Andalusia HOA is working with the Feral Cat Foundation to deal with feral cats in the Association.
  - Ron has attempted to contact the new superintendent of the CA School for the Deaf to partner with Andalusia and the Feral Cat Foundation to address the problem on their campus.
  - Association to continue dialogue with school superintendent and possibly contact the local assembly member for assistance.
- Bay Alarm Radio Wave Failures
  - Bay Alarm began radio replacements on 7/21. Work should be completed within 2 weeks.
- National Night Out will be celebrated at the Association on August 1<sup>st</sup>.
